I give the UAYA the right and permission to copyright, and/or use, and/or publish photographic portraits, pictures, or likenesses of me depicted during my stay at camp, through any media, including, but not limited to newspapers and/or the Internet and, for art, advertising or any other lawful purpose. Furthermore, I understand that for unbecoming conduct I can be expelled from camp, without reimbursement of cost, at the absolute discretion of the management, Camp Director and/or Medical Director, and that I can be barred from participation in future camps and/or entry upon the UAYA camp grounds. I have been made aware of the rules and regulations of the UAYA Camp and Administration in Ellenville and agree to abide by them. The undersigned hereby releases, indemnifies and holds harmless, the UAYA, its officials, officers, directors, counselors, agents, employees, volunteers, chaperones, coaches, trainers and representatives, from any claim arising out of any injury to the undersigned resulting from my participation in the camp, including any activities sponsored, directed or conducted by the UAYA during said camp."

## **Tabir Druzhynnykiv 2009 – Rules and Regulations** **(Please note that the below rules and regulations are a combination of Tabir and Oselia CYM rules.)**

1. No alcohol, smoking, or motorized vehicles allowed on the territory of the new Tabir; No drugs, explosives, knives (or other weapons, including pellet guns, etc.) allowed anywhere on the territory of Oselia;
2. No co-habitation of men and women is permitted.
3. Only registered participants of Tabir are allowed on the territory of Tabir.
4. All participants are required to take part in the Zdyv program (in full uniform) on Sunday--this includes Mass, Manifestatsia and Defiliada.
5. New York State Law prohibits anyone under 21 years of age to purchase and/or consume Alcoholic Beverages. Any participant under the age of 21 found consuming alcohol or determined to be under the influence of alcohol or any controlled substance shall be expelled from the Tabir. Note: Proof of age (government issued picture I.D.) will be required of all participants.
6. Do **NOT** drink and drive - it endangers the lives of others as well as your own, and it is against the law.
7. All participants are reminded that they are on Private Property. Anyone caught defacing CYM property will be asked to leave the Oselia and shall be responsible for any resulting damages. Refusal to leave or make restitution may result in criminal prosecution.
8. Speed limit at the resort center is 5 MPH.
9. Curfew of all loud noise is from 12 midnight to 9:00 a.m. Unregistered guests must leave premises by curfew.
10. Parking and camping is allowed in designated areas only.
11. Open campfires are prohibited.
12. All pets, generators, weapons, ATV's and motorcycles are forbidden on premises.
13. All participants are responsible for their own safety and security as well as the security of their personal items and vehicles anywhere on the territory of Oselia, including the Tabir. The Management of Oselia and Tabir Administration have no responsibility for lost or stolen items.

**The Management of Oselia and Tabir Administration, in their sole and absolute discretion, have the right to remove anyone from the Tabir and/or Oselia for improper behavior or violation of any of the above Rules & Regulations, as well as to exclude such person(s) from participation in any future Tabir and/or future entry upon the grounds of Oselia.**
