The undersigned further agree not to make any claim of demand nor bring any proceeding or action against any person, firm, or corporation which might claim contribution or indemnity from the release parties arising out of or in relation to the matters herein released or discharged.

In the event that any of the provisions of this Release or any part thereof are unenforceable or declared invalid for any reason whatsoever, such unenforceability or invalidity shall not affect the enforceability or validity of the remaining clauses of the document and such unforeseeable or invalid clauses of parts thereof shall be severable from the remainder of this document.
