#### National Shooting Day – Sunday 25<sup>th</sup> March 2007

The national shooting day on Sunday  $25^{\text{th}}$  March 2007 will begin with Registration at 10.30am at the Halychyna rifle and pistol range at Tarasivka. The cost per competitor will be £5.00, payable at registration.

After registration there will be a brief refresher talk in the shooting technique.

The **rifle** competition will be supervised by two range officers, a range officer per two entrants and is open to children aged 10 and over. The competition will be split into 3 categories:-

- 10-12 years of age
- 13-15 years of age
- 16+

The **pistol** competition is open to Silver badge holders and over 16's. This will take place at the right side of the range and will be supervised by a dedicated pistol range officer. The competition will be split into 2 categories as follows:-

- Silver badge holders under 16
- 16+ (and adults)

#### <u>Field Target</u>

This is open to gold badge holders and adults. The course has had an extra lane added. At 40m, the longest yet, to challenge the determined expert shot!

The course of fire will be arranged as follows:-

The competitors will be allowed two siting in cards of five shots each. After these siting in cards, the competitors will shoot 5 pellets on each lane. Each competitor will have their score recorded on a score sheet by a dedicated score person. 2 targets are required per lane i.e. 1 knock down plus 1 frangible. In the event of a tie, a shoot off will take place.

# N.B. Field target competitors wishing to take part in the rifle/pistol competition should do so before competing in the field target competition.

The issue of disputed marking will be addressed by the club chairman, in the event of any dispute with the chief score person, whose decision is final, as per the NSRA (National Small-boar Rifle Association) regulations 2001. The score person will use the NSRA regulation .177 rifle and pistol scoring gauges as stipulated in the NSRA regulations 2001.

All range instructions will be delivered by the duty range officers. Any person found to be in contravention of any range officers command or any range regulation will be asked to leave the range immediately. The health and safety of the competitors is paramount and every attempt to ensure their safety will be taken.

Competitors not actively taking part on the range will be asked to stay behind the firing line in the clubhouse. They will be asked to maintain a quiet atmosphere conducive for the competitors on the firing line. If the day turns out to be wet, a tarpaulin will be available to cover the firing point to allow shooting to continue. Competitors should bring with them suitable clothing to cater for the possible wet and muddy conditions.

All the competition details will be shot in the standing position at the firing point without resting or leaning on the bench. The latter will be a disqualifying offence. The course of fire will be completed when the last competitor to achieve a winning score remains.

Each participating competitor will receive a certificate of attendance. Trophies will be presented to the winner from each category.

Any competitor, who has not yet got the bronze, silver or gold awards and attains the level of competence for any of the aforementioned awards during the shooting competition, will be awarded the appropriate badge.

Attached is a "shooting day consent form" which must be completed by a parent/guardian for any person under 18 who will be attending the competition without a parent/guardian.
