

## **PARENT (GUARDIAN) AGREEMENT**

I (we) further agree to indemnify, protect and hold harmless said UAYA, its officers, board members, supervisors, agents, servants, employees, and all private persons or organizations volunteering services without charge to supervise or chaperone said minor while on the educational/camping tour from any claim or liability whatsoever, including, but not limited to personal injury, property damage, court costs, attorneys' fees and interest, however caused, as a result of said minor participating in the educational/camping tour. I (we) recognize that there are certain risks of physical injury inherent with some of the planned activities which include but are not limited to hiking, paint-ball, white water tubing, horseback riding and canoeing, and I (we) agree to assume the full risk of such injury.

I (we) further agree that the UAYA, its officers, agents, and/or employees reserve the right to terminate the participation of the above named minor for failure to behave and act in accordance with the UAYA's regulations on conduct for the subject tour, for failure to follow the instructions and directions of the tour supervisor (s) and/or chaperones, or for any acts of conduct of the above minor deemed by the UAYA, its officers, agents and/or employees, to be detrimental to or incompatible with the interest, harmony, comfort, or welfare of the tour as a whole. If the participation of the above minor is terminated, only the funds not actually used will be refunded, and the minor will be sent home at my (our) expense.

I (we) agree that the UAYA, its officers, agents, and/or employees reserve the right at any time prior to or during the tour to make cancellations, changes or substitutions or in emergencies or changed conditions or in the interest of the group, and to alter, prior to tour departure, the costs

in order to meet unexpected changes, as the announced fee was based on current tariffs, rates and expenses which are subject to change or re-estimation.

It is understood and agreed that some of the suppliers of services for this tour are independent contractors and are not agents, employees or servants of the UAYA or its affiliates. Further waivers may be required pursuant to these independent contractors' requirements. It is also understood and agreed that the UAYA assumes no responsibility or liability and the undersigned hereby agrees to hold harmless the UAYA from any and all claims, damages or causes of action for damages, or for delays or expenses, in connection with the tour and its related activities, including but not limited to the security of any personal property.
